## of 25.7.2011

### adopting a national programme part 1 for Turkey under the IPA-Transition Assistance and Institution Building component for the year 2011

#### THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 1085/2006 of 17 July 2006 establishing an Instrument for Pre-Accession Assistance (IPA)<sup>1</sup>, and in particular Article 14(2)(a) thereof,

Whereas:

- (1) Regulation (EC) No 1085/2006 lays down the objectives and main principles for preaccession assistance to candidate countries and potential candidates.
- (2) In accordance with Article 7 of Regulation (EC) No 1085/2006, the assistance should be provided through multi-annual or annual programmes, which can be established by country and by component. These programmes should be drawn up in accordance with the general policy framework referred to in Article 4 of Regulation (EC) No 1085/2006 and the relevant multi-annual indicative planning document referred to in Article 6 of that Regulation.
- (3) The Council has established an Accession Partnership for Turkey<sup>2</sup>. The Commission has adopted on 28 June 2011 a Multi-annual Indicative Planning Document 2011-2013 for Turkey<sup>3</sup> which presents indicative allocations for the main priorities for pre-accession assistance to that country.
- (4) Therefore, and having regard to the project proposals submitted by Turkey, the national programme for Turkey part 1 under the IPA Transition Assistance and Institution Building Component for the year 2011 identifies the priorities (1) to make progress in the critical areas of rule of law in order to tackle key reforms of the judiciary and fundamental rights; (2) to adopt the EU *acquis* in areas where there is complex legislation or costly requirements to adopt EU standards in areas such as transport, agriculture, food safety, environment, climate change and energy; (3) and to support Turkey in its economic and social development and to enhance competitiveness; thereby contributing to the achievement of the Copenhagen criteria.
- (5) This Decision meets the requirements of Article 90 of Commission Regulation (EC, Euratom) No 2342/2002 of 23 December 2002 laying down detailed rules for the

implementation of Council Regulation No  $1605/2002^4$  and constitutes thus a financing decision within the meaning of Article 75 (2) of Council Regulation (EC, Euratom) No 1605/2002 of 25 June 2002 on the Financial Regulation applicable to the general budget of the European Communities<sup>5</sup>.

- (6) The administrative capacity of Turkey is sufficiently developed to allow for implementation of this programme by decentralised management, as provided for in Article 53c of Regulation (EC, Euratom) No 1605/2002.
- (7) The Commission concluded on 11 July 2008 a Framework Agreement with the Government of Turkey on the rules for co-operation and implementation of preaccession assistance.
- (8) It is appropriate to implement the project *TR2011/0324.02 Improvement of civilian oversight in Turkey Phase II* in joint management with the United Nations Development Programme (hereinafter: "UNDP") taking into account earlier successful cooperation between the Commission and UNDP and the latter's previous experience in the particular area in Turkey focused in this project.
- (9) The measures provided for by this Decision are in accordance with the opinion of the IPA Committee.

HAS DECIDED AS FOLLOWS:

### Article 1

The national programme for Turkey under the IPA-Transition Assistance and Institution Building component for 2011 part I, as set out in the Annex, is hereby adopted.

This programme shall be implemented by decentralised management with ex-ante controls, with the exception of project *TR2011/0324.02 Improvement of civilian oversight in Turkey – Phase II* which shall be implemented by joint management with UNDP. To that effect, two Financing Agreements shall be concluded between the Commission and the Government of Turkey in conformity with the Framework Agreement concluded between the same parties.

### Article 2

The maximum amount of the European Union assistance shall be EUR 81 378 500 to be financed through Article 22.02.01 of the general budget of the European Union for the year 2011.
