# COMMISSION IMPLEMENTING DECISION

of 9.10.2019

**amending Commission Implementing Decision C(2018) 8171 of 5.12.2018 adopting the Annual Action Programme for Turkey for the year 2018**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012<sup>1</sup>, and in particular Article 110 thereof,

Having regard to Regulation (EU) No 236/2014 of the European Parliament and of the Council of 11 March 2014 laying down common rules and procedures of the implementation of the Union's instruments for financing external action<sup>2</sup> and in particular Article 2(4 ) thereof,

Whereas:

- (1) By its Decision C(2018) 8171 of 5.12.2018 the Commission adopted the Annual Action Programme for Turkey for the year 2018.
- (2) It is now necessary to modify the annex to the said Decision, in order to entrust the World Bank with tasks under indirect management to implement part of Action 5 “Energy”, due to its technical expertise in the energy sector. Furthermore, the co-financing by the beneficiary country for Action 5 is decreased.
- (3) Commission Implementing Decision C(2018) 8171 of 5.12.2018 should therefore be amended accordingly. Article 110 of Regulation (EU, Euratom) 2018/1046 establishes detailed rules on financing decisions.
- (4) The measures provided for in this Decision do not fall in the categories of measures for which the opinion of the IPA II Committee set up by Article 13 of Regulation (EU) No 231/2014 of the European Parliament and of the Council of 11 March 2014 establishing an instrument for Pre-accession Assistance (IPA II)<sup>3</sup> is required. The IPA II Committee should be informed of this Decision within one month following its adoption.
