THE EUROPEAN COMMISSION.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2024/2509 of the European Parliament and of the Council of 23 September 2024 on the financial rules applicable to the general budget of the Union ¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2024/792² of the European Parliament and of the Council of 29 February 2024 establishing the Ukraine Facility, and in particular Article 38 thereof,

Whereas:

- (1) By Decision C(2024)4604 final³, the Commission adopted the Commission Implementing Decision on the financing of the Ukraine Facility pillar III for 2024 part II, and the adoption of the second part of the annual work programme of pillar III for 2024 including three actions.
- (2) It is necessary to modify the action "Technical Cooperation Facility for Ukraine 2024", Annex I of the Commission Implementing Decision C(2024)4604 final, to increase the budget of the action by EUR 105 683 844, allocated to Union programmes benefiting Ukraine by Council Decision (CFSP) 2024/1470 of 21 May 2024 amending Council Decision 2014/512/CFSP concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine⁴ and to the Ukraine Facility by Council Regulation (EU) 2024/1469 of 21 May 2024 amending Regulation (EU) No 833/2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine, and the contribution from the Kingdom of

Council Decision (CFSP) 2024/1470 of 21 May 2024 amending Decision 2014/512/CFSP concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine. – Council Regulation (EU) 2024/1469 of 21 May 2024 amending Regulation (EU) No 833/2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine. – Commission Implementing Regulation (EU) 2024/1673 of 6 June 2024 on laying down rules for the application of Council Regulation (EU) No 833/2014 as regards reporting and the implementation of revenue operations for the financial contribution due to the Union.

- Denmark as external assigned revenue⁵ in accordance with Article 7 of Regulation (EU) 2024/792.
- (3) The amendment of the Annex I "Technical Cooperation Facility for Ukraine 2024" aims at further enhancing the objectives of the action supporting Ukranie's progressive alignment to the EU acquis as well as the implementation of the Ukraine Plan, while strengthening the country's resilience and capacity to respond to the impacts generated by Russia's war of aggression, in particular the reparation of critical energy infrastructures.
- (4) Therefore, Decision C(2024)4604 final should be amended accordingly.
- (5) The proposed assistance is to comply with the conditions and procedures set out by the restrictive measures adopted pursuant to Article 215 TFEU⁶.
- (6) This amendment is in accordance with the opinion of the Ukraine Facility Committee.

HAS DECIDED AS FOLLOWS:

Sole Article

Commission Implementing Decision C(2024)4604 final is amended as follows:

(1) [Article 2 is replaced by the following article:

"Article 2

The maximum Union contribution for the implementation of the work programme for 2024 is set at EUR 260 683 844, and shall be financed from the appropriations entered in budget line 16 06 03 01 of the general budget of the Union:

EUR 258 673 632 of the general budget of the Union for 2024;

EUR 2 010 212 of the general budget of the Union for 2024.

The amount referred to in the first paragraph includes contributions from the Kingdom of Denmark to the general budget of the European Union as external assigned revenue as provided for in the attached annex.

The appropriations provided for in the first paragraph may also cover interest due for late payment.

The implementation of this Decision is subject to receipt of the external assigned revenue from the Kingdom of Denmark in 2024."

(2) The Annex I is replaced by the text set out in the Annex to this Decision.

The increased budget is composed of: EUR 103 673 632.75 (from budget line 16 06 03 01), stemming from the profits generated by the frozen Russian assets; DKK 30 000 000 (EUR 4 020 423.75 as per InforEuro August 2024 rate) as external assigned revenue contribution from Denmark, payable in two tranches of DKK 15 000 000 in 2024 and in 2026.
