Bringing Waste water treatment facilities online

Kosovo has a chronic lack of facilities for treating sewage, which often means rivers and groundwater become contaminated. This is why the EU is helping Kosovo meet the cost of installing treatment plants and ensuring correct operation.

A pilot project in Skenderaj/Srbica has at last allowed a modern treatment plant to come into operation. The two-phase process – mechanical and biological – purifies and recycles the sewage, so that it can be returned to rivers without posing a risk to the environment or human health.

EFFECTIVE START-UP

The plant has capacity to serve 8,000 inhabitants. Construction was completed several years ago, but start-up was delayed by some property issues. These have since been solved, and the EU role here was to ensure effective start-up of the plant, conduct full testing of it by checking purity levels of the effluent for over several months, and providing extensive training for the personnel who operate the plant.

Working with the Ministry of Environment and Spatial Planning and the Kosovo Environment Agency, the EU has invested around EUR 60 million to date in refurbishing treatment plants and pumping stations, and related improvements to water networks.

Waste-water treatment plants in small settlements are also under construction in Junik, Kuk and Kosave, Dragash/Dragaš, Skivjan, Gjakovë/Đakovica, Medvec and Vrelle, Lipjan/Lipljan municipality.

A STRATEGY FOR MANAGING WATER

But improving the situation is not just a question of upgrading plants and networks. The right regulatory and management systems are also needed, to ensure services of an acceptable standard and at fair prices. So the EU has also been providing expert help to the Kosovo administration.

Now it is working on a water strategy for the whole of Kosovo, to map out the need for further waste water treatment plants and the rest of the water network.
