THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument - Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009² and in particular Article 23(3) thereof,

Whereas:

- By Decision C(2021)9348 final³, the Commission adopted the individual measure in (1) favour of the Republic of Moldova for 2021.
- It is necessary to modify the action "State and Resilience Building Contract in favour (2) of the Republic of Moldova" and to increase the budget of the measure by EUR 75 million in order to mitigate the impact of the ongoing war in Ukraine on energy markets in Moldova.
- (3) Therefore, Decision C(2021)9348 final should be amended accordingly.
- The proposed assistance is to comply with the conditions and procedures set out by the (4) restrictive measures adopted pursuant to Article 215 TFEU⁴.
- This amendment is in accordance with the opinion of the Committee established (5) pursuant to Article 45 of Regulation (EU) 2021/947.

HAS DECIDED AS FOLLOWS:

The maximum Union contribution for the implementation of the measure for 2021 and 2022 is set at EUR 135 000 000.00, and shall be financed from the appropriations entered in budget line 14.0201110f the general budget of the Union.

The appropriations provided for in the first paragraph may also cover interest due for late payment"
