METHODOLOGY

DATA COLLECTION	Second half of 2017
SAMPLE UNIVERSE	Population of the country 18+
SAMPLE SIZE	At least 1000 respondents per country
TYPE OF SAMPLE	Stratified random sample representative for country population
DATA COLLECTION METHOD	Face-to-face in all countries except the former Yugoslav Republic of Macedonia (CATI)
POST-STRATIFICATION	By gender, age, education, type of settlement and region

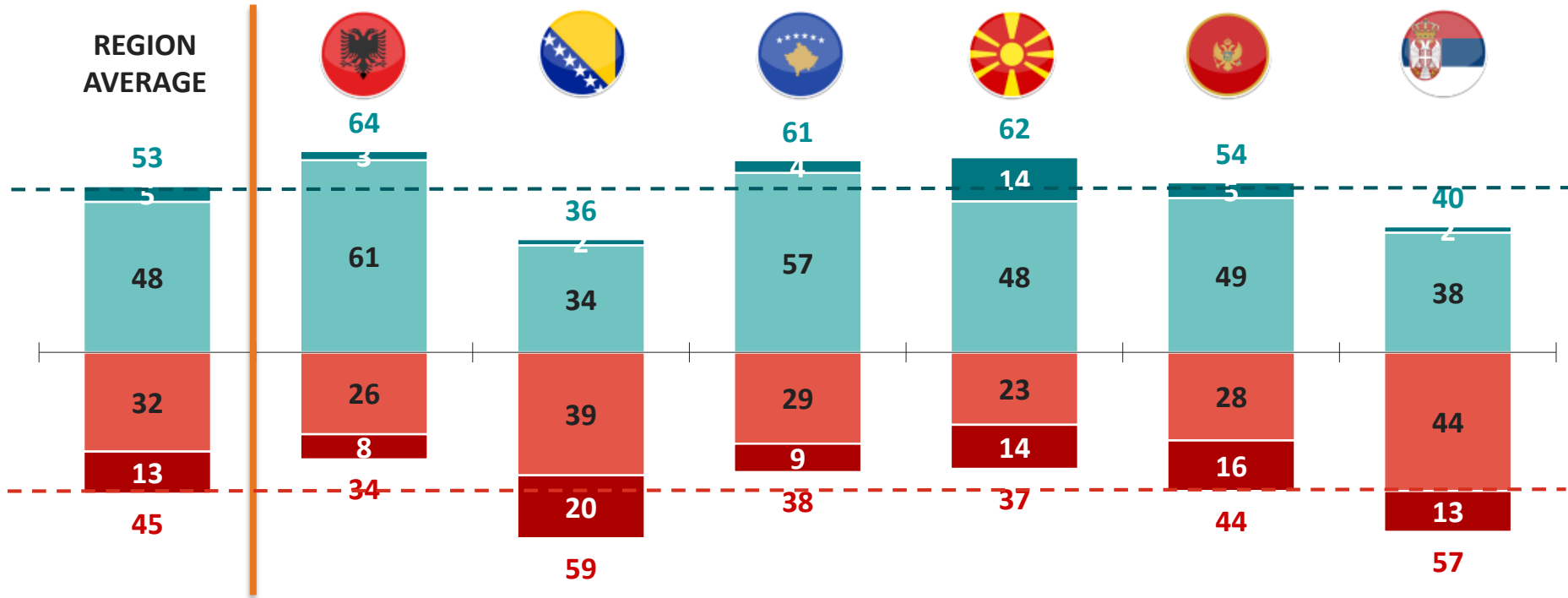

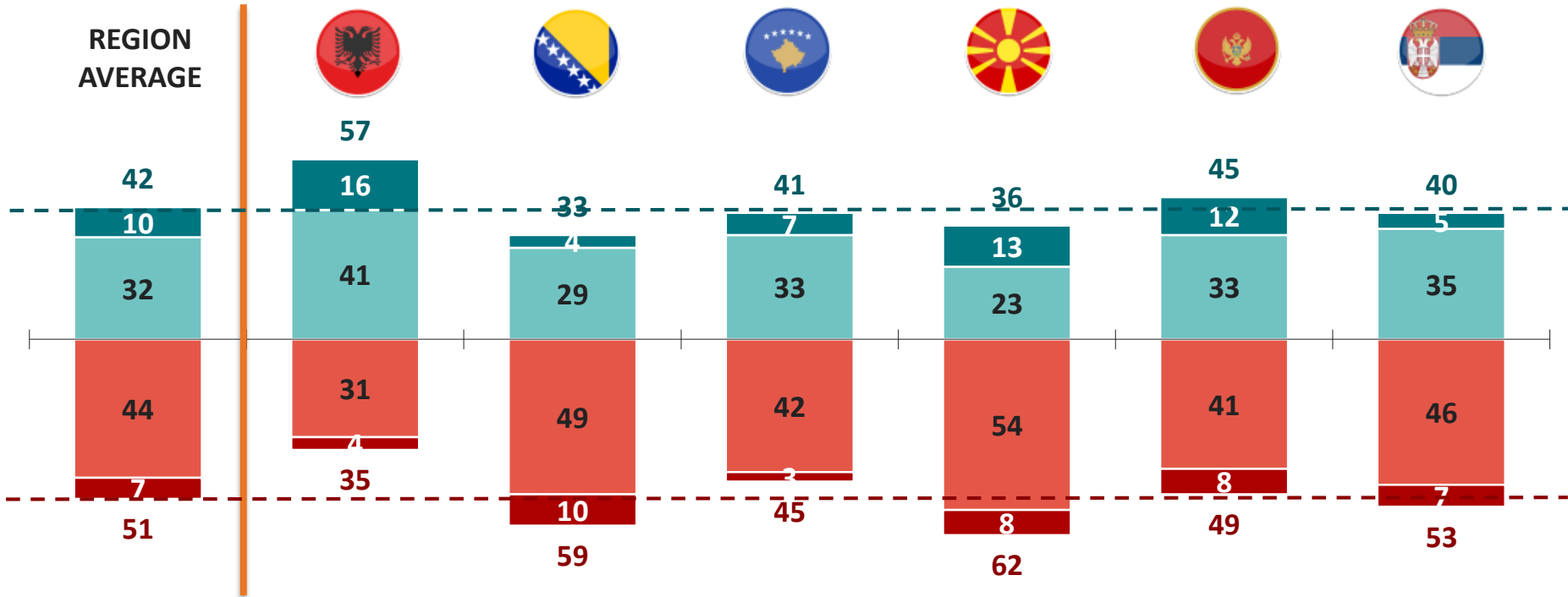

In your opinion, to what extent are information about relevant issues, events and developments accessible through the media to citizens in the country?

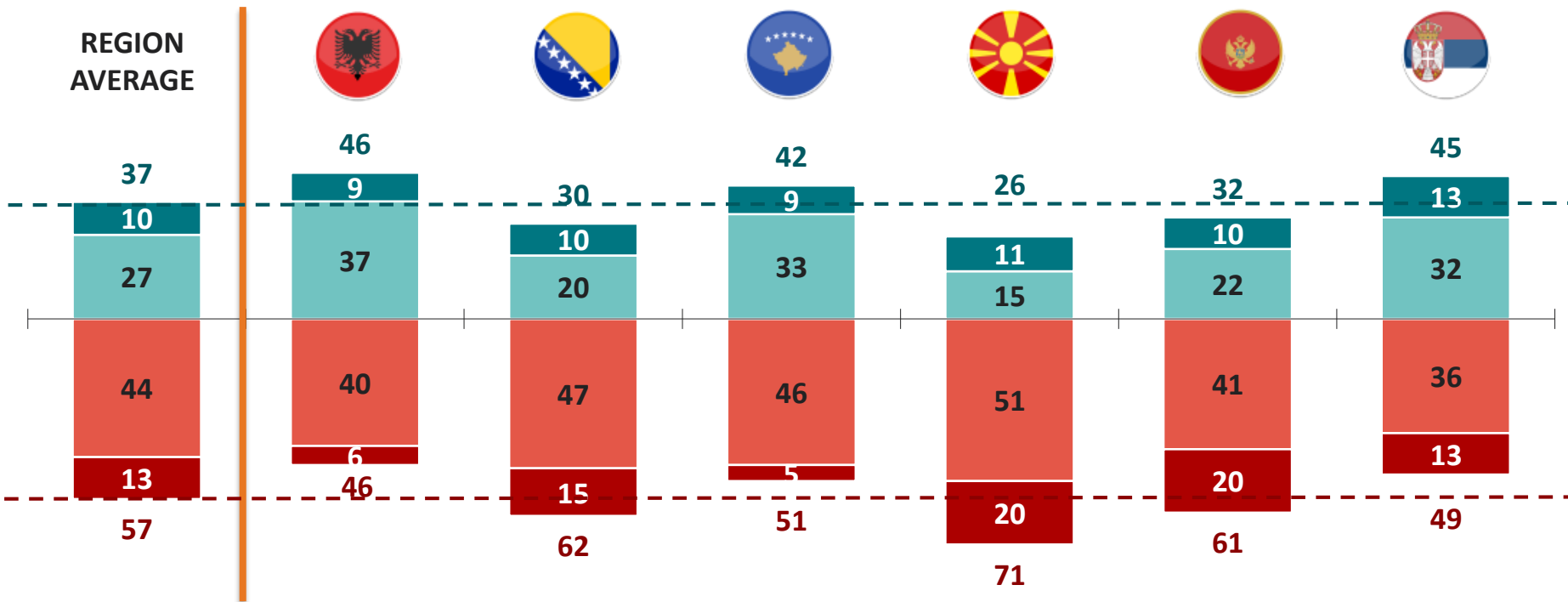

In your opinion, to what extent journalists and media outlets in our country are free to express their views and report critically about relevant news?

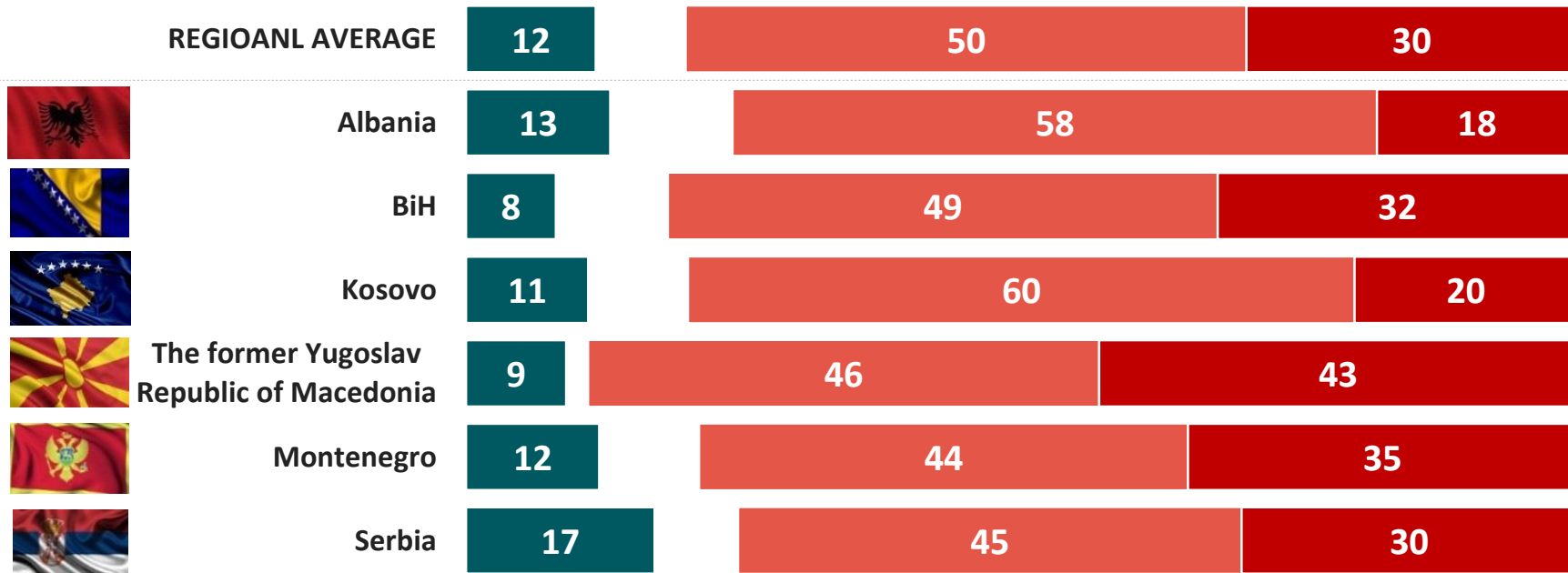

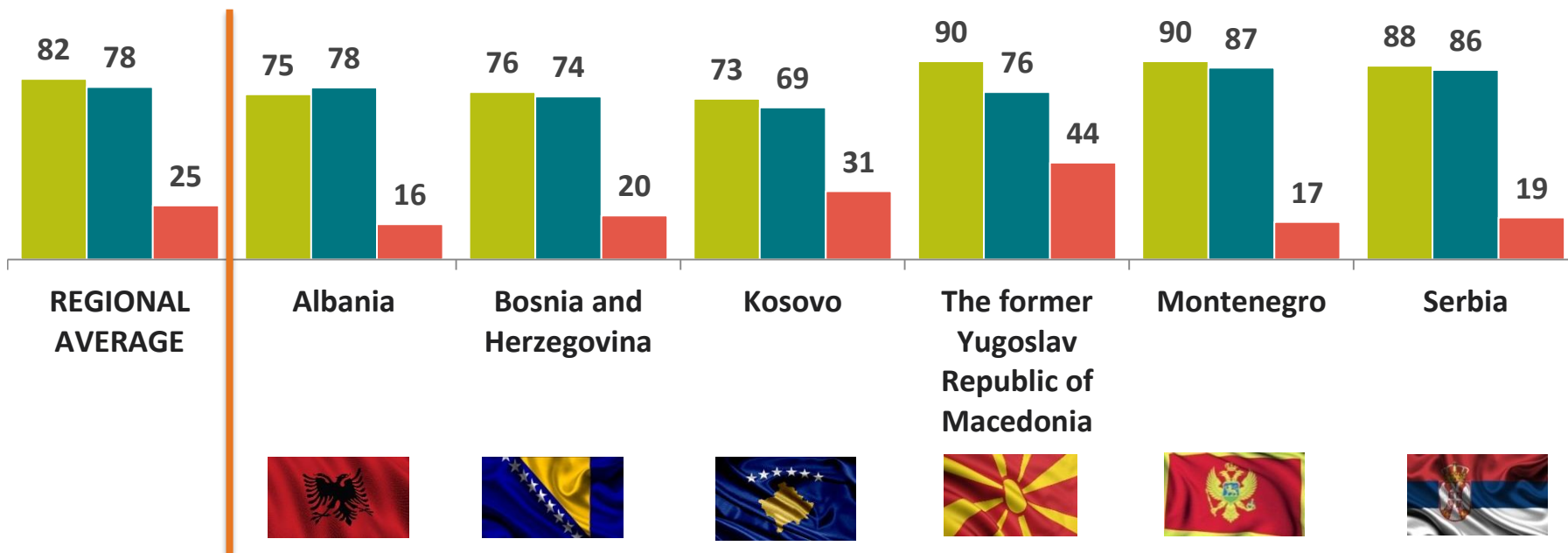


IMPORTANCE OF FREEDOM OF SPEECH AND MEDIA FREEDOM

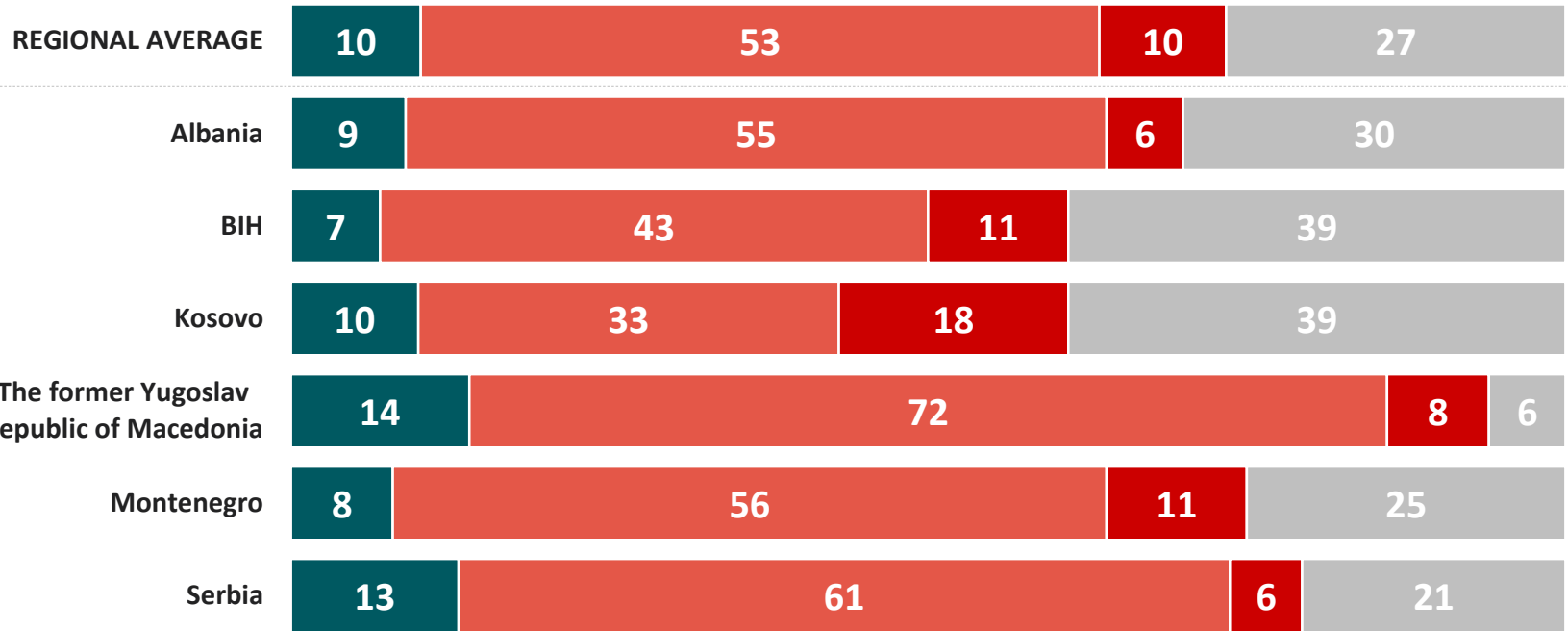

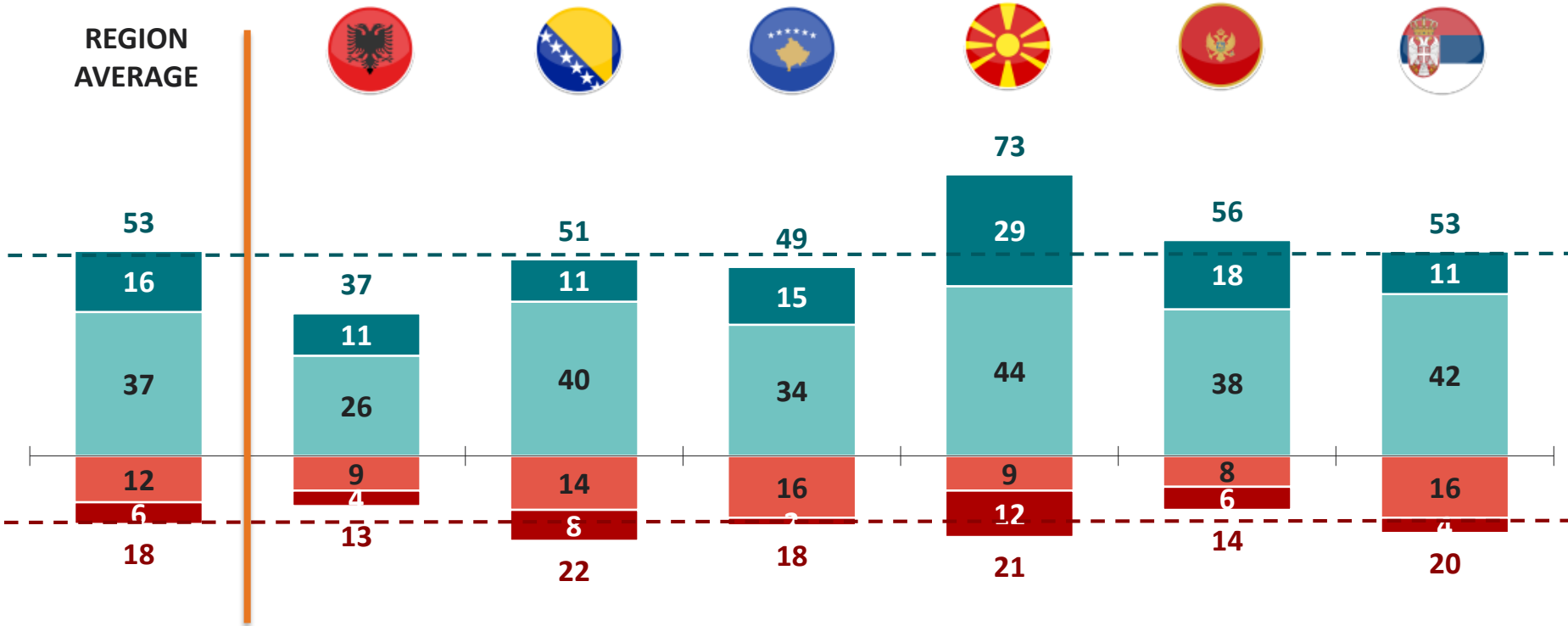
