2 RATIONALE

2.1 PROJECT CONTEXT: ISSUES TO BE TACKLED AND NEEDS ADDRESSED

EU Programmes are a series of integrated measures accepted by the European Commission aimed at strengthening the co-operation among the Member States regarding EU policies for a period of time. EU Programmes are financed from the general budget of the European Union, covering different areas: from environmental protection, energy and transport to the development of entrepreneurship and competitiveness, and they represent significant

instruments for defining and conducting internal EU policies. Montenegro has the opportunity to participate in these programmes; however, as a main condition of participation, an annual fee has to be paid to the budget. This action represents an opportunity for Montenegro to be better prepared for accession and also to familiarise itself with EU policies and working methods.

2.2 LINK WITH MIPD AND NATIONAL SECTOR STRATEGIES

The project will contribute to all sectors of the MIPD by encouraging Montenegro's participation in several EU programmes before its accession, thus contributing to its preparation and to better absorption of funds and better implementation of projects after its accession.

2.3 LINK WITH ACCESSION PARTNERSHIP (AP) / EUROPEAN PARTNERSHIP (EP) / STABILISATION AND ASSOCIATION AGREEMENT (SAA) / ANNUAL PROGRESS REPORT

Protocol 8 of the Stabilisation and Association Agreement provides the legal basis by establishing the general principles of Montenegro's participation in Union Programmes. It specifies that:

- Montenegro shall contribute financially to the general budget of the European Union corresponding to the specific programmes in which it participates,
- the specific terms and conditions for its participation in each particular programme will be determined by agreement, in the form of a Memorandum of Understanding, between the European Commission and Montenegro,
- Montenegro may apply for Community external assistance under IPA, and the conditions governing the use by Montenegro of the Community assistance shall be determined in a financing agreement.

In the **National Plan for Integration** (NPI) of Montenegro, Union Programmes are expected to be part of the pre-accession strategy to EU (e.g., regarding the FP7, under the mid-term priorities (3.25.1.3), the “entry ticket” is planned for using IPA funds).

2.4 PROBLEM ANALYSIS

The objective of the participation of candidate countries and potential candidates in Union programmes is to enable the countries to familiarise themselves with the methods and policies of the European Union.

The “*Thessaloniki Agenda for the Western Balkans: Moving towards European Integration*”, endorsed at the European Council on 20 June 2003 indicates that the “*Union programmes will be opened to SAP countries along the lines established for the participation of candidate countries*”

Consequently Framework Agreements similar to the ones concluded with the candidate countries have been signed with all the Western Balkan countries to establish the general principles for their participation in Union programmes. The former state union of Serbia and Montenegro had signed Framework Agreement on participation in Union Programmes on 29th June 2005, which came into force on 27 July 2005. Following Montenegro' independence, as

Montenegro was not covered any more by the Framework Agreement signed with Serbia and Montenegro, its provisions were included in the Stabilisation and Association Agreement signed with Montenegro, as its Protocol 8².

In accordance with the Protocol 8 of the Stabilisation and Association Agreement, the specific terms and conditions regarding each particular programme, in particular the financial contribution payable (the "entry ticket"), are determined by agreement, in the form of a Memorandum of Understanding (MoU), between the Commission and Montenegro.

The IPA programme can be used to co-finance the financial contribution ("entry-ticket") to be paid each year by Montenegro. The part of the financial contribution which is financed from the national budget should increase progressively, and a gradual and selective approach to participation should be maintained in Union programmes.

MoUs are already in force with Montenegro concerning the Seventh Framework Programme for Research and Development (FP7), the Entrepreneurship and Innovation Programme (EIP), Culture 2007-2013 Program, ICT Policy Support Programme 2011 and Customs 2013, and MoUs are expected to be signed by the end of 2012 for the centralised actions of the Lifelong Learning Programme and for the Europe for Citizens programme

2.5 LINKED ACTIVITIES AND DONOR COORDINATION

Previous annual IPA programmes were used to co-finance the financial contribution ("entry-ticket") paid the previous years by Montenegro for its participation in the Community/Union programmes.

2.6 Lessons learned

The experience of neighbouring countries shows that participation in Union programmes is an extremely important feature of a successful pre-accession strategy. The benefits drawn from participation in the EU programmes should not be measured by the number of projects submitted by or involving these countries. Rather through the country's participation in the EU programmes, its citizens, companies and national administrations of the candidate countries or potential candidates are joining in co-operation and exchange networks with their counterparts in EU countries in very different areas.

For instance, Montenegrin researchers did not participate significantly in 6th Framework Programme for Research, and Montenegro took part only in 4 projects: ERA West Balkan, SEE-ERA-NET, SEEREN2 and SEEGRID2. Even though this participation was weak, it contributed to building up the capacity of the Ministry, and setting the grounds for development of networks between Montenegrin researchers and those from the region, as well

as their partnerships with European researchers. New opportunities were open not only to the experienced researchers, but to young scientists as well, which is considered to be an important feature of this process. However, participation in the first two years of FP7 has shown that the number of successful projects with Montenegrin participants is increasing, and it is expected that the positive trends will continue through the Programme implementation, especially since institutional support to participants has developed.

It is therefore beneficial for the country's progressive integration into the EU networks to join a wide range of programmes before its accession. The entry tickets to be paid would however have constituted a serious obstacle for the authorities of Montenegro to agree on Montenegro's participation if they would have to be covered entirely by the State budget. Such a participation in a wide range of programmes in different areas would not have been possible without the guarantee of IPA partial reimbursement.

IPA programming experience has shown that line ministries should increase their planning capacities. In order for IPA funds to be available for reimbursement during the participation of the country in a given year, IPA funds need to be earmarked in the IPA national programme of the previous year. Montenegro should carefully plan financial contributions, as the part of the entry ticket which is financed from the State budget should increase progressively during the participating years.

3 DESCRIPTION

3.1 OVERALL OBJECTIVE OF THE PROJECT

To support the beneficiary country to participate in a wide range of Union Programmes, thus contributing to the preparation of Montenegro's accession and to the understanding of European Union policies and underpinning values by institutions and citizens of Montenegro.

3.2 SPECIFIC OBJECTIVE(S) OF THE PROJECT

To co-finance the costs of the "entry-tickets" which Montenegro needs to pay in accordance with the relevant Memoranda of Understanding establishing its participation in Union programmes in areas such as education, health, science, culture, citizenship, employment, entrepreneurship and innovation, taxation and custom systems.

3.3 RESULTS

Ensured swift reimbursement of the IPA part of the entry tickets (in particular for FP7, CIP-EIP, CIP-ICT PSP, Culture 2007-2013, Customs 2013, Lifelong Learning and Europe or Citizens) following the payment by Montenegro .

Indicator: Date of effective payment by Montenegro of its entry-tickets and date of transfer of IPA funds, as a partial reimbursement.

3.4 MAIN ACTIVITIES

The main activity consists of providing IPA funds as reimbursement of a part of the entry ticket for participation in the Union Programmes for which a Memorandum of Understanding is in force.

The EU contribution to the entry ticket will be negotiated between the beneficiary and the EC, normally before the MoU is signed. The participation of the beneficiary in Union Programmes shall follow the specific terms and conditions set out for each such programme in the MoU.

The Montenegrin Government has a commitment, not only to provide for the national co-financing, but also to advance the funds necessary for the payment of the total entry ticket, before it gets the partial IPA reimbursement.

The main conditionality is signature of the Memorandum of Understanding on participation in selected Union Programmes between the European Commission and the Government of Montenegro which is a precondition for participation.

Sequencing:

After the signature of the IPA Financing Agreement, the responsible line ministries sign a contribution agreement with the EU Delegation for each programme or group of programmes under their responsibility as per the following procedure:

- At the beginning of the year the various Commission services responsible for the different programmes send to the Mission of Montenegro to the EU a request for the total financial contribution (“entry ticket” for the participation in a given programme or agency (“call for funds”).
- The responsible line ministries must ensure the timely payment of the total entry ticket, within the deadlines requested in the call for funds. When making the payment for each programme, the authority in charge should quote the reference number indicated in the call for funds for the programme concerned, and send simultaneously a copy of the payment order to the relevant Commission service, to the EU Delegation and to the National IPA Coordinator.

- Upon reception of the copy of the payment order, the EU Delegation prepares the contribution agreement for each programme or group of programmes to be signed with the responsible line ministries or the National IPA Coordinator³.
- IPA funds are then transferred as reimbursement of a part of the contribution paid, on the basis of a specific contribution agreement and the request for funds by the beneficiary with a proof of payment. In case the IPA funds are transferred to the National IPA Coordinator⁴, the National IPA Coordinator then transfers the amount of the IPA support for each programme to the authority, which made the payment of the financial contribution to the programme concerned.

3.5 ASSESSMENT OF PROJECT IMPACT, CATALYTIC EFFECT AND CROSS BORDER IMPACT (WHERE APPLICABLE)

For Montenegro, participation in Union Programmes represents a major step in meeting the criteria towards EU accession in the field of science, culture, employment, entrepreneurship and innovation. It represents a key measure to make the country and its citizens familiar with the Union's policies and working methods.

Increased participation in Union Programmes is an important element in the EU integration process, as it implies participation in knowledge sharing, awareness raising and acquiring knowledge from member states of EU practices in various sectors. This knowledge can subsequently be utilised in the design and application of future projects and actions in Montenegro.

Participation in Union programmes will also encourage the active involvement of public and private institutions, NGOs, civil society institutions, universities to benefit from the EU accession process. It is expected that the knowledge and skills developed through participation in Union Programmes will be retained within the participating institutions and within the responsible ministries. It is also expected that the institutions will be able to maintain and develop the EU networks established through Union programme participation into longer term formal and informal collaboration.

3.6 SUSTAINABILITY

Through the participation in EU Programmes, Montenegro will continue to build knowledge and capacities of different stakeholders dealing with European issues and projects; actively participate in the implementation of the EU policies; support different activities of institutions, small and medium enterprises; intensify international cooperation and initiate mobility in relation to EU countries and thus become deeper involved into the European integration process.

Participation in EU Programmes will encourage the active involvement of public and private institutions, NGOs, civil society institutions and universities to benefit from the EU accession process. It is expected that the knowledge and skills developed through participation in EU

Programmes will be retained within the participating institutions and within the responsible ministries.

3.7 ASSUMPTIONS AND PRE-CONDITIONS⁵

The responsible line ministries ensure the timely payment of the total entry ticket, as well as timely and documented requests for reimbursement. Responsible ministries continuously facilitate the support to the applicant's participation in the programmes (in particular FP7, CIP-EIP, CIP-ICT PSP, Culture 2007-2013, Customs 2013).

4 IMPLEMENTATION ISSUES

The activity will be implemented as a reimbursement of a part of the entry ticket after the entry ticket has been paid, on the basis of a specific contribution agreement.

4.1 INDICATIVE BUDGET

The Ministry of Foreign Affairs and European Integrations governs the association and accession process of Montenegro to the EU, coordination of the negotiation process with the EU, coordination of the harmonisation of Montenegrin legislation with the EU legislation, coordination of translation and management of data basis for the process of support to the translation process and coordination and evaluation of the programmes of technical and financial EU support

For each selected programme, the respective line Ministry will be responsible for co-ordination of project activities as follows:

The Seventh Framework Programme (FP7) bundles all research-related EU initiatives together under a common roof playing a crucial role in reaching the goals of growth, competitiveness and employment; along with a new Competitiveness and Innovation Framework Programme (CIP), Education and Training programmes, and Structural and Cohesion Funds for regional convergence and competitiveness. It is also a key pillar for the European Research Area (ERA).

The broad objectives of FP7 have been grouped into four categories: Cooperation, Ideas, People and Capacities. For each type of objective, there is a specific programme corresponding to the main areas of EU research policy. All specific programmes work together to promote and encourage the creation of European poles of (scientific) excellence.

The Memorandum of Understanding between the European Union and Montenegro on the participation of Montenegro to the Seventh Framework Programme for Research and Development (FP7) was signed and entered into force on the 1st January 2008.

COMPETITIVENESS AND INNOVATION FRAMEWORK PROGRAMME 2007-2013

According to the decision No 1639/2006/EC of the European Parliament and of the Council of 24 October 2006 establishing the Competitiveness and Innovation Framework Programme for the period 2007-2013, Montenegro is eligible to apply. Within the CIP programme there are three main sub-programmes:

- Entrepreneurship and Innovation Programme (EIP).
- ICT policy support programme (ICT PSP)
- The intelligent energy-Europe programme (IEE).

Montenegro participates to EIP and expressed interest in participating to ICT PSP.

a) ENTREPRENEURSHIP AND INNOVATION SPECIFIC PROGRAMME (EIP)

With this programme, the European Commission seeks to support innovation and SMEs and focuses in particular on the following objectives:

- Facilitate access to finance for the start-up and growth of SMEs and encourage investment in innovation activities.
- Create an environment favourable to SME cooperation, particularly in the field of cross-border cooperation.
- Promote all forms of innovation in enterprises.
- Support eco-innovation.
- Promote an entrepreneurship and innovation culture.
- Promote enterprise and innovation-related economic and administrative reform.

The Memorandum of Understanding between the European Union and Montenegro on the participation of Montenegro to the Union Programme “Entrepreneurship and Innovation specific Programme (EIP) of the Competitiveness and Innovation Framework Programme (2007 to 2013)” was signed and entered into force on the on 20 May 2008.

b) ICT POLICY SUPPORT PROGRAMME (ICT PSP)

This programme aims at stimulating innovation and competitiveness through the wider uptake and best use of ICT by citizens, governments and businesses, particularly Small and Medium-sized Enterprises. Public organisations can take further advantage of advances in ICT to provide more efficient and higher quality services. The ICT policy support programme will help overcome the hurdles hindering the wider and better use of ICT in high growth sectors of public interest like health, inclusion or public administrations.

Montenegro expressed its interest to join ICT PSP in December 2009. The MoU entered into force on 27 April 2011.

CULTURE 2007-2013

The Programme has been established to enhance the cultural area shared by Europeans the development of cooperation activities among cultural operators from countries taking part in the Programme, with a view to encouraging the emergence of European citizenship. The Programme is aimed at three specific objectives organised in strands (more information available on <http://eacea.ec.europa.eu/culture/programme/documents/2010/may/EN.pdf> promotion of the trans-national mobility of people working in the cultural sector, support for the trans-national circulation of cultural and artistic works and products, and promotion of inter-cultural dialogue.

The Memorandum of Understanding between the European Union and Montenegro on the participation of Montenegro in the Culture programme signed on 23 November 2009 in Brussels and Memorandum of Understanding took effect as of the budget year 2010.

CUSTOMS 2013

Customs 2013 provides national customs administrations with the possibility to create and exchange information and expertise. It allows developing and operating major trans-European IT systems in partnership and establishing various human networks by bringing together national officials from across Europe.

The Customs 2013 programme's overall objective is to support and complement the action undertaken by Member States in ensuring the effective functioning of the internal market in the customs field by:

- Making national customs administrations act as if they were one;
- Reinforcing security and safety within the EU and at the external border;
- Strengthening the fight against fraud and protecting the financial and economic interests of the EU and its Member States;
- Increasing the competitiveness of European business by modernising and speeding up customs procedures (trade facilitation).

The programme finances different types of activities, notably (i) developing and operating centrally deployed and trans-European IT systems (ii) supporting joint actions between customs officials (such as seminars, working visits, working groups,

steering groups, etc.) to facilitate the exchange of good practice and (iii) developing common training tools for the use of customs officials across Europe.
