### **Good Practice** *Post from Serbia: Pre-empting EU rules*

*As a good example of Serbia's efforts to comply with the EU acquis we can cite the changes taking place in the Serbian Wine Sector. By means of a Twinning project, the sector has made a decisive step forward recently.*



*In November 2006, the Serbian Ministry of Agriculture, Forestry and Water Management of the Republic and the Spanish Ministry of External Affairs have joined their forces in the Twinning project 'Capacity Building for the Regulation of the Serbian Wine Sector'. The project leans on the long experience of the Regional Ministry of Agriculture, Livestock and Rural Development of La Rioja. This is a Spanish region whose vine and wine model of Qualified Designation of Origin are a world level reference.*

*Thanks to this Twinning project, Serbia now has its first Vineyard Register that includes, for the moment, 25 % of the estimated vineyard surface of Serbia. Moreover, during the last months of*

*2008, the Wine Group inside the Serbian Ministry of Agriculture, Forestry and Water Management sent to the Wine Makers the forms for the voluntary inscription in the Wine Cellar Register. At this moment, they are recording the data that they have received and they estimate that they are have received the data for 50-60 % of the total Wine Cellars existing in Serbia.*

*The most important is the fact that these Registers have been carried out on a completely voluntary basis, pre-empting the regulation that in the European Union will force the inscription of all vine plots and cellars to the above-mentioned Registers.*

*A good cooperation between all stakeholders (representatives of the sector, the beneficiary Ministry and the member State ministry) was essential to come to this result. Thanks to the voluntary registration by the sector, with help of the Serbian and Spanish officials, the future of the Serbian Wine Sector looks bright: it may well bring back to the Serbian Wine the prestige and recognition it deserves.*
