## confirming Commission Implementing Decision C(2022)1588 final

### THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012<sup>1</sup>, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument - Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009<sup>2</sup> and in particular Article 23(2), Article 23(3), Article 23(4), Article 23(6) and Article 24 thereof,

### Whereas:

- (1) By Commission Implementing Decision C(2022)1588 final<sup>3</sup>, the Commission amended several Commission Implementing Decisions financing the European Union bilateral and regional cooperation with Ukraine. This decision was adopted on 11 March 2022 as immediately applicable implementing act, in accordance with the procedure referred to in Article 25(4) of Regulation (EU) 2021/947. Pursuant to Article 45 of Regulation (EU) 2021/947 which refers to Article 8 of Regulation (EU) no 182/2011 of the European Parliament and of the Council laying down the rules and general principles concerning mechanisms for control by Member States of the Commission's exercise of implementing powers<sup>4</sup>, it is now necessary to replace the provisional Commission Implementing Decision C(2022)1588 final by the present decision. By its Decisions listed under Article 1, the Commission adopted Special Measures and Annual Action Programmes in favour of Ukraine and Neighbourhood East Regional, to be financed from the general budget of the European Union.
- (2) Following the unprovoked and unjustified military aggression initiated on 24 February 2022 by the Russian Federation against Ukraine, the urgent need arose to provide a

- quick response to support the Ukrainian authorities and the population under these unprecedented circumstances.
- (3) Consequently, it is considered appropriate to modify a number of Commission Implementing Decisions financing the European Union bilateral and regional cooperation with Ukraine, in order to extend the areas of interventions defined in the Action Documents attached therein in order to address some of the most urgent needs resulting from the war situation.
- (4) The amended Action Documents will provide for a broader framework of eligible activities, allowing to address the immediate needs linked *inter alia* to civil protection, cyber security, societal and economic resilience and rehabiliation needs.
- (5) Therefore, the Implementing Decisions listed under Article 1 should be amended accordingly.
- (6) The proposed assistance is to comply with the conditions and procedures set out by the restrictive measures adopted pursuant to Article 215 TFEU<sup>5</sup>.
- (7) It is appropriate to authorise the award of grants without a call for proposals and to provide for the conditions for awarding those grants.
- (8) The amendment provided for in this Decision should apply retroactively as of the start of the military aggression, initiated on the 24 February 2022.
- (9) This decision is in accordance with the opinion of the Committee established pursuant to Article 45 of Regulation (EU) 2021/947.

The amendment provided for by this Decision shall apply to costs incured as from 24 February 2022 in accordance with article Article 193(2) of Regulation 2018/1046 on the financial rules applicable to the general budget of the Union and under the specific conditions foreseen in the Annex of the present decision.
