THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument - Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009² and in particular Article 23(2) thereof

Whereas:

- (1) By Decision C(2022)2421 final³, the Commission adopted the financing of the annual action plan in favour of the NDICI Neighbourhood East Region part 2 for 2021 including four actions.
- (2) It is necessary to modify the action EU4Youth: Youth Engagement and Empowerment so as to add an additional component for continued support to coordination and policy development and dialogue of the overall EU4Youth initiative in the Eastern Partnership region and related budget increase for the action by EUR 2.5 million from NDICI 2022.
- (3) Therefore, Decision C(2022)2421 final should be amended accordingly.
- (4) The proposed assistance is to comply with the conditions and procedures set out by the restrictive measures adopted pursuant to Article 215 TFEU⁴.
- (5) This amendment is in accordance with the opinion of the Committee established pursuant to Article 45 of Regulation (EU) 2021/947.

HAS DECIDED AS FOLLOWS:

Sole Article

Commission Implementing Decision C(2022) 2421 final is amended as follows:

Article 2 Union contribution is replaced by the following article:

The maximum Union contribution for the implementation of the action plan for 2021 is set at EUR 95 190 000, and shall be financed from the appropriations entered in the budget line 14.020111 of the general budget of the Union: The appropriations provided for in the first paragraph may also cover interest due for late payment.

Annex IV is replaced by the Annex to this Decision.
