THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument - Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009² and in particular Article 23(2), (3), (4), (6) and Article 24 thereof,

Whereas:

- (1) By Commission Implementing Decision C(2022)1884 final³, the Commission amended several Commission Implementing Decisions financing the European Union regional and bilateral cooperation with the Republic of Moldova and Georgia. That Decision was adopted on 24 March 2022 as immediately applicable implementing act, in accordance with the procedure referred to in Article 25(4) of Regulation (EU) 2021/947
- (2) Pursuant to Article 45 of Regulation (EU) 2021/947 which refers to Article 8 of Regulation (EU) No 182/2011 of the European Parliament and of the Council⁴, it is now necessary to replace the provisional Implementing Decision C(2022) 1884 by this Decision.
- (3) By several Decisions listed under Article 1, the Commission adopted Special Measures and Annual Action Programmes in favour of the Republic of Moldova

- (hereinafter "Moldova") and of Georgia and the Neighbourhood East Region⁵, to be financed from the general budget of the European Union.
- (4) Following the unprovoked and unjustified war of aggression initiated on 24 February 2022 by the Russian Federation against Ukraine, the urgent need arose to provide a quick response to support the Moldovan authorities and the population under these unprecedented circumstances given the consequences of the war of aggression in terms of large-scale refugee movements to Moldova.
- (5) Also following the unprovoked and unjustified war of aggression initiated on 24 February 2022 by the Russian Federation against Ukraine, there is a need to foresee possible future needs for further quick responses to support the population and authorities of Moldova and of Georgia should the conflict escalate to other countries.
- (6) Consequently, it is considered appropriate to amend several Commission Implementing Decisions financing the European Union regional and bilateral cooperation with Moldova and Georgia, in order to extend the areas of interventions defined in the Action Documents attached therein in order to address some of the most urgent needs resulting from the Russian war of aggression, in coordination with other relevant EU services.
- (7) These amendments to Commission Implementing Decisions financing the European Union regional and bilateral cooperation with Moldova and Georgia, which will address some of the most urgent needs resulting from the war situation, will complement similar amendments to Commission Implementing Decisions financing the European Union regional and bilateral cooperation with Ukraine⁶.
- (8) The amended Action Documents will provide for a broader framework of eligible activities, allowing to address the immediate needs linked inter alia to, cyber security, societal and economic resilience and rehabilitation needs in coordination with other relevant EU services.
- (9) Therefore, the Implementing Decisions listed under Article 1 should be amended accordingly.
- (10) The proposed assistance is to comply with the conditions and procedures set out by the restrictive measures adopted pursuant to Article 215 TFEU⁷.
- (11) It is appropriate to authorise the award of grants without a call for proposals and to provide for the conditions for awarding those grants.
- (12) This Decision should apply retroactively as of the start of the war of aggression, initiated on the 24 February 2022.
- (13) The measures laid down in this Decision are in accordance with the opinion of the Committee established pursuant to Article 45 of Regulation (EU) 2021/947,

Article 1

Article 3

This Decision shall apply to costs incurred as from 24 February 2022 in accordance with Article 193(2) of Regulation (EU, Euratom) 2018/1046 and under the specific conditions provided for in the Annex to this Decision.

Article 4

The present decision repeals and replaces Decision C(2022)1884 final.
