2. Overall Objective and Project Purpose

2.1 Overall Objective

To contribute to the development of the region of Kukes, through further improving and modernising the infrastructure of the Morine-Kukes BCP.

2.2 Project purpose:

Rehabilitation and improvement of the infrastructure in Morine-Kukes BCP.

2.3 Link with AP/NPAA / EP/ SAA

The project will assist to achieve the priorities included in the proposal of the European Commission dated 06.11.2007 for a Council Decision on the principles, priorities and conditions contained in the **European Partnership** (EP) with Albania repealing Decision 2006/54/EC.

The European Partnership outlines as the short-term priority the further approximation of customs legislation and procedures with EU practices, and full implementation of the computerised system for customs declaration and customs data processing in all customs offices. As medium term priority, the General Customs Directorate should ensure continued approximation of Albanian customs legislation to the EU acquis and further increase administrative capacity to implement customs legislation and to fight corruption, cross-border crime and fiscal evasion.

The Stabilisation and Association Agreement (SAA) between the Government of Albania and the European Community has been signed in July 2006. Article 97 of the agreement aims to strengthen the cooperation in this area with a view to guaranteeing compliance with the provisions to be adopted in the area of trade and to achieving the approximation of the customs system of Albania to that of the Community.

The Customs Administration is currently part of the National Plan of the Implementation of the Stabilisation and Association Agreement (NPISAA) where are foreseen mid-term and long-term actions that aim at strengthening the administrative capacities for the implementation of customs legislation and the fight against corruption and fiscal evasion, as well as improvement of transparency and exchange of information with the Member States of EU to facilitate the implementation of measures to prevent evasion. The full list of short and medium priorities, and legislative reforms foreseen in the NPISAA, is enclosed in ANNEX IV.

2.4 Link with MIPD

This project is proposed under the area of Economic Criteria section of the IPA/ MIPD for the period 2008–2010:

2.6 Link with national/sectoral investment plans

Under the framework of the Government's Integrated Planning System (IPS), whose core aim is to match medium and annual budgeting to the policy framework, a Public Finance strategy has been drafted by the Ministry of Finance covering the period 2007-2013. In the framework of this strategy, the Directorate General of Customs should "improve and develop means for developing data exchange and increasing cooperation between the Albanian Customs and the business sector, other institutions of the Republic of Albania, other law enforcement institutions; and with the Customs authorities of other countries, EU institutions and international organisations in the fields of implementation of customs legislation, prevention of violations, control and investigation."

3. Description of project

3.1 Background and justification:

The Border Crossing Point in Morine-Kukes is a second category customs house, serving as a communication point between the Republic of Albania and Kosovo (under UNSCR 1244).

The customs building has been partially refurbished in year 2002, but still the actual condition of the infrastructure is not satisfactory. The parking lot serves only for three-four heavy means, the administrative building esp. roof and heating system are either amortised, or out of function. The ground asphalt is damaged, the control equipment is missing (scanner, detective bridge, etc.).

In view of the completion of the project for the highway connecting the Albanian main port to Kosovo- Durres-Kukes-Morine, the flow of movement of goods and passengers is expected to grow in this BCP. As a consequence it is expected that the engineering and logistic infrastructure is being improved, in order to better suit to the new conditions.

3.2 Assessment of project impact, catalytic effect, sustainability and cross border impact

Impact – The project is expected to have an economic impact due to the good infrastructure of the border crossing point, through the facilitation of the traffic flow and efficient, qualitative service on similar parameters from both countries.

Through this action will be released traffic flow in the border and to facilitate the movement of people and goods and will improve link between Albania and countries in the North of Albania.

Also as a consequence of the construction of the new road Durres- Kukes-Morine, this BCP shall be the main border crossing in the North of Albania.

Catalytic effect – The project will trigger possible revisions and/or updating of development regional plans and will bring greater benefits to the local communities in the border and will have an impact to the economical and social growth in Albania and in the region.

Sustainability – The Ministry of Finance will ensure the necessary funding for the maintenance of the BCP after the project will be completed.

3.4 Activities:

Activity 1 Rehabilitation of the border crossing point of Morine-Kukes

This activity will be implemented through a works contract (Contract 1.1). The contract will include the following:

- Extension of the existing parking lot with 5000 m²
- Partial reconstruction of the administrative building
- Lay asphalt paving for all the customs area + parking lot

- Other infrastructure related activities needed for the CBC connection

This activity will be co-financed by the Government of Albania through a separate contract (Contract 1.2). The contract will cover the costs for the expropriation process of 5.000 m2 and of a one-storey building of 250 m2 (90 000 EUR).

Activity 2 Design, preparation Tender dossier, supervision (Contract 2.1)

This activity will be implemented through a service contract. The contract will include the following:

- Project design
- Preparation tender dossier
- Supervision of the works in site

3.5 Conditionality and sequencing:

Construction of parking lot is subject to the expropriation process of a land (5 000 m2) and a one-storey building (250 m2) to be completed by the Albanian Government. Therefore the works contract covered by IPA funds will be launched and signed only after completion of the expropriation process
