## **modifying the Commission Decision C(2012)3815 on the 2012 special measure for Syria and Syrian refugees to be financed from the general budget of the European Union**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 1638/2006 of the European Parliament and of the Council of 24 October 2006 laying down general provisions establishing a European Neighbourhood and Partnership Instrument (ENPI), and in particular Article 13 thereof,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002<sup>1</sup> (hereinafter referred to as 'the Financial Regulation'), and in particular Article 84 thereof,

Having regard to Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of Regulation No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union<sup>2</sup> (hereinafter referred to as 'the Rules of Application'), and in particular Article 94 thereof,

Whereas:

- (1) Commission Decision C(2012)3815 adopted on 07 June 2012 approved the "2012 Special Measure for Syria and Syrian refugees".
- (2) The purpose of the present modifying Decision is to allow for a change in the management mode of the Action Fiche "Support for the Syrian Population affected by the unrest" - Annex 3 to the original Decision.
- (3) The Commission may entrust budget-implementation tasks under joint management (indirect management with an international organisation) to the entity identified in this Decision, subject to the conclusion of a contribution agreement. The responsible authorising officer has ensured that this entity complies with the conditions of Article 53d of Council Regulation (EC, Euratom) No 1605/2002 of 25 June 2002 on the Financial Regulation applicable to the general budget of the European Communities<sup>3</sup> (hereinafter referred to as 'the Financial Regulation 1605/2002') and of Articles 35 and 43 of its Implementing Rules<sup>4</sup>.
- (4) The special measure provided for in this Decision is in accordance with the opinion of the ENPI Committee set up under Article 26 of Regulation (EC) No 1638/2006,
